Memorandum of understanding between Indian College of Anaesthesiologists (ICA) and Indian Society of Anaesthesiologists (ISA)

1. Agreement reached between Indian Society of Anaesthesiologists (ISA) and Indian College of Anaesthesiologists (ICA) on 21-11-2009 at the annual meeting of ICA and later on 28-12-2009 at the annual general body meeting of ISA.
2. These Changes were brought out as resolutions following bilateral discussions and later approved. The changes are made to accommodate ICA as part of ISA. Once when trust deed of ICA is amended with the changes, ICA will be part of ISA and there will be no further remarks entertained in any ISA forum regarding authenticity of ICA or its formation.
3. The changes to be brought in trust deed of Indian College of Anaesthesiologists are
 - a. "Indian College of Anaesthesiologists (ICA), will be functioning as the academic wing of Indian Society of Anaesthesiologists (ISA) under overall guidance and supervision (control) of ISA.
 - b. Any qualified anaesthesiologist could become a member of Indian College of Anaesthesiologists, provided the individual is a member of ISA. Disciplinary control of ISA over members of ISA will be accepted by ICA and if a member of ISA is disciplined / categorized by ISA, the same action will be applicable in ICA also. ICA is permitted to give membership under exceptional circumstances to persons of academic repute / organizational repute, even when not a member of ISA, subject to ratification by ISA. ICA will have separate membership application, registry and membership fee.
 - c. It is resolved to issue membership of ICA with the evidence of ISA membership card. The ICA has to send report quarterly about the membership registration to ISA.

- d. All the ICA meetings / activities should be done under the banner of ISA.
- e. The President of ISA should be the Ex-officio chairman of ICA. In addition, Secretary ISA, Treasurer ISA, the immediate Past President, two members from GC of ISA and President and Secretary of ISA Delhi (Metro Branch) will be members of ICA executive council along with the other (8) eight members from the committees of ICA. Executive committee of ICA function as autonomous body.
- f. The members from the sister / speciality societies need not be included in the executive committee of ICA.
- g. The postgraduate number of Indian Journal of Anaesthesia published by ISA, in October, from now onwards, will be compiled and prepared by ICA, with its own executive editor, but to be printed and dispatched by Editor, IJA. The total cost will be borne by ISA.
- h. The Secretary of ICA / Registrar will be ^{special} ~~permanent~~ invitee to the GC meetings of ISA where in, the ICA update GC on the activities and progress of ICA. ~~will be presented.~~

This draft 'MOU' will be entered on a non-judicial stamp paper (Rs 50/-) and signed by concerned authorized officers before trust deed is changed.
