- 1. Nomination (signed copy) for these posts are received from 15-09-2021 and must reach the Office of the Honorary Secretary, Indian Society of Anaesthesiologists (National) before 5:00 PM on 30-09-2021, by Registered Post with ACK due / Speed Post / Courier / E-mail /By hand at the Office of ISA National. A scanned copy of the nomination form should be submitted online / by E Mail also to isanhq@gmail.com and secretaryisanhq@gmail.com. The list of all Nominations received will be published in ISA Office and ISA website on 01-10-2021. Incomplete Nominations will be rejected. The list of all valid Nominations will be published on 8-10-2021. The Candidate, Proposer and Seconder must be Active Life Members of ISA with eligibility to vote online in their respective Zone.
- 2. Last date for withdrawal of the Nomination is 15-10-2021 before 5:00 PM and the final list of eligible candidates will be published in ISA Office and ISA website on 16-10-2021.
- 3. Last date for Registering for Online Voting is 01-10-2021 up to 5:00 PM.

- 4. The final voter lists (online only) will be published in the ISA Website (www.isaweb.in) on 15-10-2021.
- 5. Elections will be held online only. No manual voting
- 6. Online voting will be open for five days, from 01.11.2021 (08:00 AM) to 05.11.2021 (05:00 PM). Real time count of voting and names of persons who have voted will be available in ISA website. The final details of votes polled will be published and the result will be declared immediately after voting is closed on 05-11-2021.

#### 7. Eligibility criteria:

- a) Contestant must be a continuous member of society for not less than ten years for the posts of Vice President and President Elect.
- b) Contestants for the Posts of Vice President and President Elect should have served one term of office in the Governing Council earlier.
- c) Contestant must be a continuous member of society for not less than five years for the post of Governing Council Member ISA.
- d) Contestants should have attended three of the last five Annual General Body Meetings and must have signed in the AGBM Register.
- e) Each nomination must be accompanied by self attested proof of the nomination fee. The Nomination fee (Non refundable) should be in the form of NEFT / cash deposit in favour of "Indian Society of Anaesthesiologists" (ISA National) payable at SBI, Rohtak, Haryana (Current A/c No. 35292412841, IFS Code SBIN0000706). The nomination fee is Rs. 20,000/- for the Post of President Elect and Rs 10,000/- each for other posts.
- 8. All Life Members of ISA as on 14.09.2021 who have registered their E- Mail ID and Mobile Number with ISA NHQ only are eligible to Vote. New Members enrolled on or after 15.09.2021 and old members who do not register their E Mail ID and Mobile Number with ISA NHQ will have all the privileges of his class of Membership, except the right to Vote in this Election.
- 9. The nomination of candidates to the election shall be made in the prescribed format, which is enclosed herewith. Every nomination together with the written consent of the candidate to contest the election duly proposed by one and seconded by another Active ISA Life Member

shall be sent to the Honorary Secretary, ISA National so as to reach him not later than 5:00 PM on 30-09-2021.
